

AMENDMENT TO THE  
REVOCABLE TRUST OF VERNON BECK, JR. AND DOLORES ANN BECK  
DATED JUNE 30, 1998

Pursuant to the powers reserved to me as Settlor in that Trust instrument dated June 30, 1998, in which VERNON BECK, JR. and DOLORES ANN BECK are named as Trustees, and the said DOLORES ANN BECK died on October 30, 2020, I hereby amend the Trust instrument in the following respects.

1. ARTICLE ONE, subparagraphs B., C., D., and E. are hereby cancelled and are of no further effect. In lieu of the cancelled provisions, the following is substituted:

"B. **PRIMARY TRUSTEES:**

I hereby designate myself as the primary trustee of this trust. As long as I am alive, I may exercise dominion and control over any and all of the trust assets, except as to amendment, partition, or revocation of this trust, which shall be pursuant to the provisions of Article Three.

C. **SUCCESSOR TRUSTEE:**

I designate GENEVIEVE FERNANDEZ as the successor trustee of this trust. My successor trustee is to assume the duties as trustee hereunder upon my resignation, death, disappearance, or if I am certified in writing to be incompetent as provided under Article Five of this Declaration of Trust. Except as otherwise specified within the provisions of this Declaration of Trust, in the event of my incompetency or resignation, my successor trustee is to use the income and assets of this trust exclusively for my health, education, support, and maintenance.

2. ARTICLE TWO, subparagraph "A.2.b." is hereby cancelled and is of no further effect. In lieu of the cancelled provision, the following is substituted:

"b. The net proceeds of this trust shall be distributed as follows:

- (1) THREE PERCENT (3%) to JOSEPH CANGELOSI;
- (2) THREE PERCENT (3%) to VERONICA SCOT;
- (3) FOUR (4) PERCENT (4%) to CHRISTIAN CHILDREN'S FUND;
- (4) THREE PERCENT (3%) to LISA COVINGTON;
- (5) SIX PERCENT (6%) to NATIONAL RIFLE ASSOCIATION;


- (6) FIVE PERCENT (5%) to HUMANE SOCIETY FOR CATS AND ANIMALS ON HARBORVIEW;
- (7) The balance to GENEVIEVE FERNANDEZ.”

2. The right to amend or revoke the foregoing amendment in whole or in part is hereby reserved.

In all other respects, I ratify and confirm all of the provisions of the Trust instrument.
